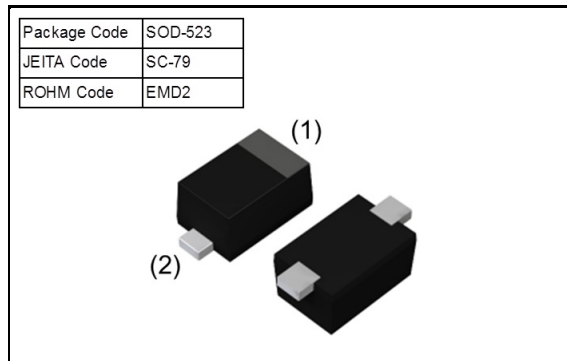

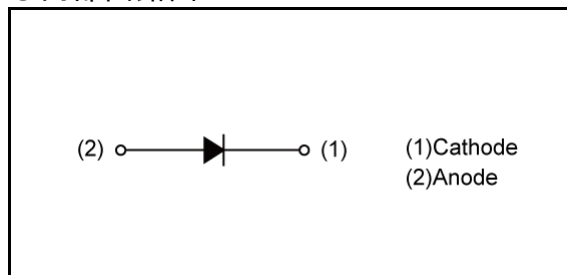
使用上の注意

● 外形図



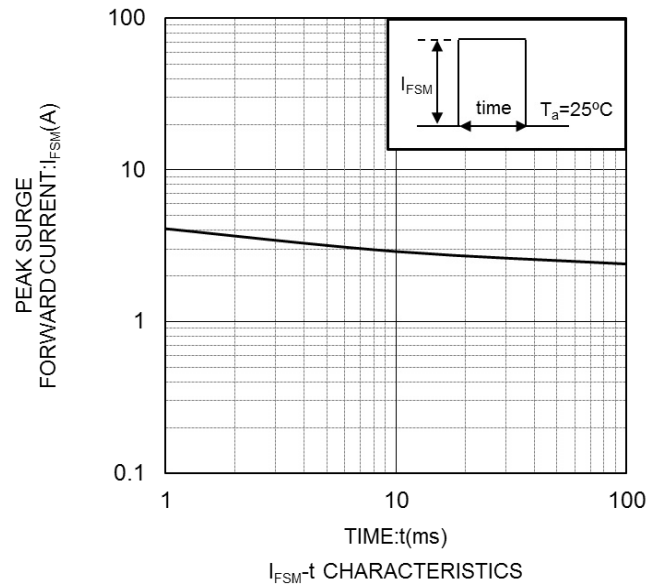
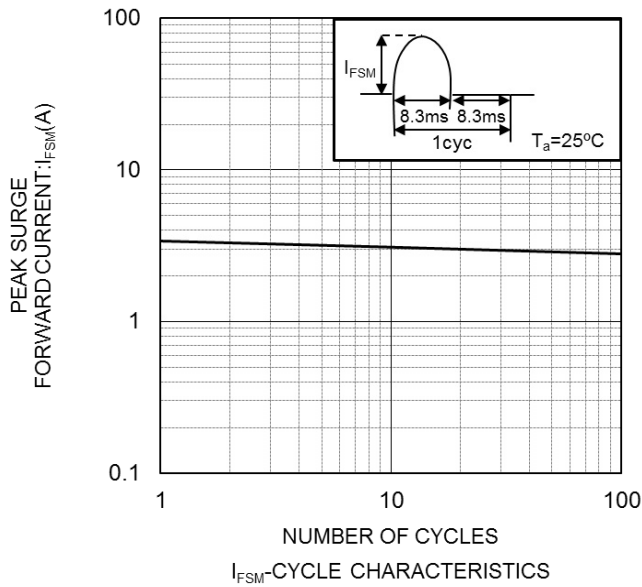
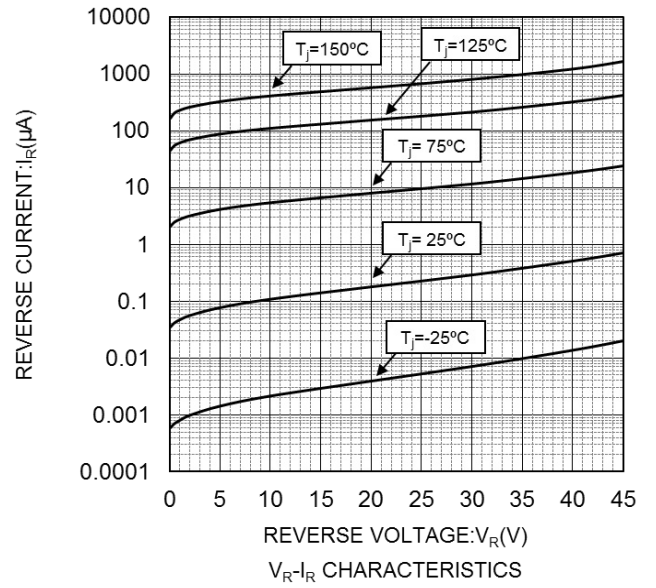
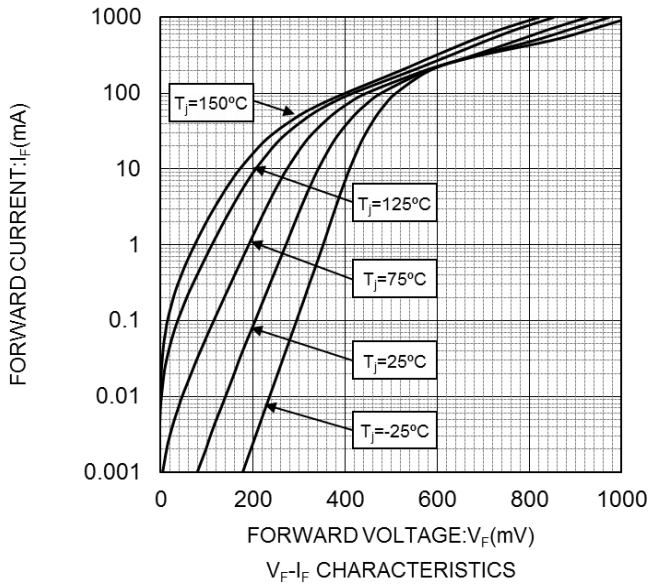

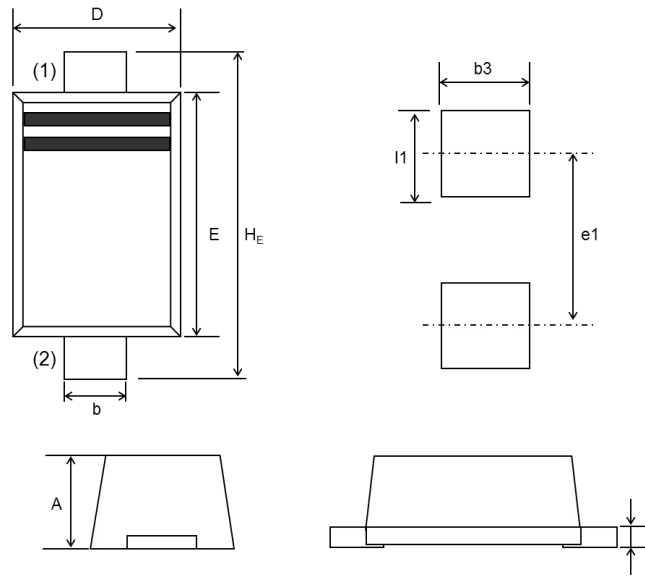

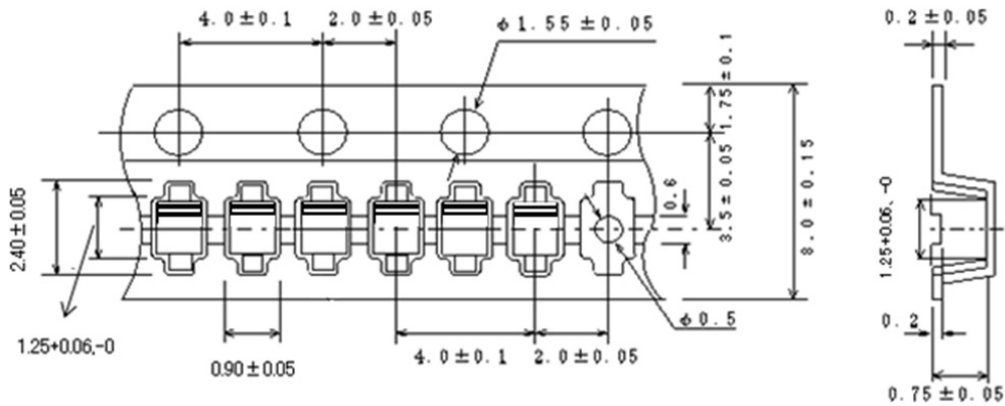
